Sealed quotations are invited on behalf of the President of India by the Chief Administrative Officer, Raja Ramanna Centre for Advanced Technology, Indore-452013 for supply of medicines from licensed retail druggist/chemists located within the Indore city on "as and when required basis".

**Eligibility Criteria:-**

1. The chemist must hold valid license as on the date of submission of Bid in specified Forms 20,21 and 21-C (for continuance of retail licenses, if required) issued by the Drug Control Authority of the State under the provisions of Drugs and Cosmetics Act, 1940. The successful Bidder will further ensure that their license remain valid on the date of bid opening and till the end of the contract period and the copy of the same should be attached with the tender documents.
2. The chemist must not have been convicted by the State drugs authorities and no case should be pending under the Drugs and Cosmetics Act and Rules.
3. The chemist shop/commercial establishment should be situated within the Municipal limits of Indore.
4. Tax clearance certificate should be available with the bidder. A copy of the latest Tax deposit Challan should also be enclosed along with bid document.
5. A copy of PAN should also be enclosed along with bid document.
6. An undertaking to the effect that "The Bidder has gone through all the Terms & Conditions of the Tender documents & the same are acceptable to the Bidder."
7. **Bids quoting less than 15% discount on MRP (inclusive of all taxes) shall not be considered.**
