**PART A: GUIDELINES FOR E-TENDERING :-**

1.	It is mandatory for all the applicants to have <b>class-III digital signature certificate</b> from any of the licensed Certifying Agency to participate in e-tendering
2.	In order to participate in online e-tendering process, it is mandatory for the applicants to have <b>user ID &amp; password</b> to get access to the website <a href="http://www.tenderwizard.com/DAE">www.tenderwizard.com/DAE</a> . The applicants have to get registered their firm / company with the service provider, M/s ITI Limited for user ID & password. The registration shall be done by paying an annual registration fees to M/s ITI Limited and completing other formalities as mentioned in website. Validity of online registration is for one year from date of its issuance and be subsequently renewed. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required. Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and / or having adverse report on the works carried out by them in the past.</p>
3	Information and Instructions for tenderers posted on website shall form of tender document.
4	The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <a href="http://www.tenderwizard.com/DAE">www.tenderwizard.com/DAE</a> free of cost. 6	<b>On opening date, the contractor can login and see the bid opening process.</b>
7	<b>Certificate of Financial Turn Over:</b> At the time of submission of bid, contractor may upload Undertaking / Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document
8	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in <b>YELLOW</b> colour and the moment rate is entered, it turns <b>SKY BLUE</b> . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
9	Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
10	The Department reserves the right to accept / reject any prospective application without assigning any reason thereof. The department does not bind itself to accept the lowest tender and reserved to itself the authority to reject any or all of the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.
11	<b>IF ANY INFORMATION FURNISHED</b> by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in RRCAT.
12	Short listing of the agencies shall be subject to thorough verification of their credentials. The works carried out by the agencies may be inspected through a Technical evaluation committee of experts constituted by RRCAT.
13	<p><b>TAXES : TAXES :</b> i). This works comes under Works Contract. Works Contract. Taxes applicable shall be deducted from each bill paid to the contractor. ii). Contractor, should be registered as mandated in the law relevant to GST. iii). <b>The Goods &amp; Services Tax (GST)</b> as applicable in individual item need to be include in the quoted rates. Department shall not entertained any claim pertaining to GST. v). <b>Labour Welfare Cess @1%</b> of gross value of work done shall be recovered from each bill paid to the contractor. vi). <b>Income Tax and Cess</b> as applicable shall be deducted from each bill paid to the contractor. vii). Any other taxes/cess as per Government directives shall be deducted from each bill</p>

	<p>paid to the contractor, from time to time.</p> <p>viii). Contractor shall be responsible for making payment of wages through Bank/ Cheque before the expiry of 7 days from the last day of wage period. No other mode of payment shall be acceptable.</p>
14	<p>If any tenderer withdraws his tender within the validity period and before award of work whichever is earlier or make any modifications in terms and conditions of the tender which are not acceptable to the department, then the government shall without prejudice to any right or remedy, be at liberty to forfeit 50% (Fifty percent) of the earnest money absolutely.</p> <p>Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.</p>
15	<p>In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.</p>
16	<p>The successful bidder whose tender is accepted will be required to obtained Police verification certificate (PVC) issued by the office of the superintending of Police of concerned District his own cost for his all workmen i.e. Engineers, supervisors and labourers to work inside RRCAT and should quote accordingly. The PVC will be valid for three years.</p> <p>In case of receipt of any adverse charter and antecedent remarks/notification against the contractor/company/firm/proprietor and/or his contract personnel, consequent to the security vetting, RRCAT reserved absolute right to terminate the contract forthwith without assigning reason/show cause notice.
