RRCAT, Indore, on behalf of President of India invites online item rate tender through e tendering mode in two parts i.e. Part 'A' -Technical bid and Part 'B'-Financial bid, from eligible contractors on approved list of CPWD, MES, Railways, State PWDs, Public sector undertakings of State or Central government, Central autonomous bodies or those having adequate experience and capabilities to execute similar works of such magnitude in Department of Atomic Energy(DAE) for the work, "Maintenance of Plantations, Playfields incl. weed control measures, watering arrangements and misc. works at RRCAT, Indore. "

INFORMATION AND INSTRUCTIONS FOR BIDDERS FOR e-TENDERING

PART A: GUIDELINES FOR E-TENDERING :-

1.	It is mandatory for all the applicants to have class-III digital signature certificate from any of the licensed Certifying Agency to participate in e-tendering
2.	In order to participate in online e-tendering process , it is mandatory for the applicants to have user ID & password to get access to the website www.tenderwizard.com/DAE . The applicants have to get registered their firm / company with the service provider, M/s ITI Limited for user ID & password. The registration shall be done by paying an annual registration fees to M/s ITI Limited and completing other formalities as mentioned in website. 3.	The applicants, who have already obtained such valid user ID and password from M/s ITI Limited, for any other work of DAE, need not obtain fresh user ID and password for the purpose of participation in the present tender.
4.	The services for e-tendering in RRCAT / DAE is provided by M/s ITI Ltd., Tender wizard Help Desk Centre, B-1/5A, 2 nd Floor Main Nazafgarh Road Near Janakpuri Metro Station (East) Janakpuri, New Delhi-110058, Fax No: 91-11-25618721 Ph No: 011-49424365, e-mail : daehelpdesk@tenderwizard.co.in
5.	The tender shall be submitted online in the prescribed format before the date and time as mentioned in NIT. No other mode of submission is acceptable.
6.	The applicants have to upload the details of e payment towards the cost of processing fees, before the last date & time and download the tender documents from the e-tendering portal only, otherwise, it will not be possible for them to upload the tender on the e-tendering portal. Note : Downloading the tender documents without confirmation of payment details on web site : www.tenderwizard.com/DAE shall not be valid and rejected summarily Tenderers are advised to upload their documents well in time, to avoid last minutes rush on the server or complications in uploading. RRCAT, in any case, will not be responsible for any type of problem in uploading the documents. No hard copies for tender submission shall be entertained.
7.	Online submission of the tender document after the due date and time shall not be permitted. Time being displayed on e-tendering portal of RRCAT shall be final and binding on applicant. No hard copies for tender submission shall be entertained.
8.	The tenderers are advised to submit their documents on line well before the due date & time. RRCAT shall not be responsible for any delay in submission of documents for any reason including server and technical problems.
9.	In case of any problem with the submission of the online tender document, the applicant may have the assistance of help desk or use the help manual given on the said website or mobile and e-mail mentioned above.
10.	Bidders may please note the following also regarding taxes and other liabilities etc: (i) This work comes under Works Contract . Taxes applicable for such contracts must therefore be included in the quoted rates. (ii) The contractor should be registered as mandated in the law relevant to GST. (iii) The Goods & Services Tax (GST) as applicable in "individual materials, equipments, tools etc." and "individual items as well as overall offer" need to be included in the quoted rates/tender offer. Department shall not entertain any claim pertaining to reimbursement of GST, WCT, Turnover Tax, Income Tax, Corporation Tax, Labour Cess and all other taxes

etc. lawfully paid by the contractor.

(iv) Labour Welfare Cess @ 1 % of gross value of work done shall be deducted from each running bill & final bill.

(v) Applicable, income tax/corporation tax, cess, TDS on GST, security deposit etc. shall be deducted from each running bill & final bill.

(vi) The bidder must possess valid EPF & ESIC registration as per relevant laws. The bidders need to deposit EPF&ESIC with appropriate authority. The reimbursement for the same shall be made upon submission of satisfactory & genuine documentary evidence. The bidder therefore need not consider EPF & ESIC in the quoted rates.

(vii) The payment of wages to labourers should be made through bank.

1	Contractors who fulfil the following requirements shall ONLY be eligible to apply. (Joint ventures are not accepted).
1.1	Proof of registration with Government / Semi Government organizations like CPWD, MES, BSNL, Railways, State PWDs etc. in appropriate class OR having experience in execution of similar nature of works.
1.2	Should have satisfactorily completed the works as mentioned below during the last seven years ending on previous day of last date of submission of tender. Three similar works each of value not less than 40% of the estimated cost put to tender. or Two similar works each of value not less than 60% of the estimated cost put to tender. or One similar work of value not less than 80% of the estimated cost put to tender. Important Note : a) Similar work shall mean:- Horticulture works of labour oriented in nature. b) Cost of work shall mean gross value of the completed work including the cost of materials supplied by the Client, but excluding those supplied free of cost. The value of executed works shall be brought to the current costing level by enhancing the actual value of work at a simple rate of 7% per annum; calculated from the date of completion to the last date of receipt of applications for tender.
1.3	Should have had average annual financial turnover of at least 100% of the estimated cost put to tender on works during the last three years ending 31st March, 2018 . (Scanned copy of Certificate from CA to be uploaded)
1.4	Should not have incurred any loss in more than two years during the last five years ending 31st March, 2018 .
1.5	Should have Bank solvency of minimum amount of 40% of the estimated cost put to tender (not older than one year from the date of opening of tender)
1.6	List of works in hand & List of similar works carried out by them for last 7 years indicating i) Agency for whom executed, ii) Value of work, iii) Completion time as stipulated and actual, or present position of the work.

1.10	UNDERTAKING as under:- I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in DAE in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. 2	The intending bidder must read the terms and conditions as per "SECTION – 1: NOTICE INVITING TENDERS" OF "CONDITIONS AND CLAUSES OF CONTRACT – 2008" carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required. Department reserves the right of Non-consideration of Tender documents of the agencies who are not fulfilling the NIT stipulations and / or having adverse report on the works carried out by them in the past.
3	Information and Instructions for tenderers posted on website shall form of tender document.
4	The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/DAE free of cost. The detailed NIT can also be viewed & downloaded from www.rrcat.gov.in.
5	The bid can only be submitted after uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any Scheduled Bank towards EMD in favour of "PAY AND ACCOUNTS OFFICER, RRCAT,INDORE" and Processing Fee in favour of "ITI Limited, New Delhi" and other documents as specified.
6	On opening date, the contractor can login and see the bid opening process.
7	Certificate of Financial Turn Over: At the time of submission of bid, contractor may upload Undertaking / Certificate from CA mentioning Financial Turnover of last 3 years or for the period as specified in the bid document.
8	Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in YELLOW colour and the moment rate is entered, it turns SKY BLUE . In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO) .
9	Canvassing in connection with tenders are strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
10	The Department reserves the right to accept / reject any prospective application without assigning any reason thereof. The department does not bind itself to accept the lowest tender and reserved to itself the authority to reject any or all of the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.
11	IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in RRCAT.
12	Short listing of the agencies shall be subject to thorough verification of their credentials and inspection of works carried out by them, through a Technical evaluation committee of experts constituted by RRCAT.
13	Hard copies of any documents as well as original copy of any financial instruments towards cost of EMD, shall be submitted at the specified time before opening of technical bid , failing which the bid shall be rejected.
14	If any tenderer withdraws his tender within the validity period and before award of work whichever is earlier or make any modifications in terms and conditions of the tender which are not acceptable to the department, then the government shall without prejudice to any right or remedy, be at liberty to forfeit 50% (Fifty percent) of the earnest money absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.
15	In the case of bids in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
16	The successful bidder whose tender is accepted will be required to obtain Police verification certificate (PVC) issued by the office of the superintending of Police of concerned District at


his own cost for his all workmen i.e. Engineers, supervisors and labourers to work inside RRCAT and should quote accordingly. The PVC will be valid for three years. In case of receipt of any adverse charter and antecedent remarks/notification against the contractor/company/firm/proprietor and/or his contract personnel, consequent to the security vetting, RRCAT reserves absolute right to terminate the contract forthwith without assigning reason/show cause notice. Under the circumstances the contractor will have no right to claim good any loss/liability that may be incurred as consequence to the above action initiated by RRCAT. RRCAT also reserves the right to forfeit in part/full performance guarantee and/or security deposit in possession of the government for failure on the part of the contractor to abide/adhere to the security instruction issued by DAE/RRCAT from time to time.

NOTE: PROSPECTIVE AGENCIES SHALL SATISFY THEMSELVES OF FULFILLING ALL THE NIT CRITERIA BEFORE SUBMISSION OF TENDER. DEPARTMENT RESERVES THE RIGHT OF NON CONSIDERATION OF TENDER OF THE AGENCIES NOT FULFILLING THE STIPULATED CRITERIA.


